- CPPDSM4039A—Conduct livestock sale by auction, and
CPPDSM4037A—Conduct auction of rural property.
- OR - the following units of competency if the statement of attainment was issued before 1 June 2012
PRDSSA23A—Conduct auction sale, and
PRDSSA32A—Conduct livestock sale by auction.
